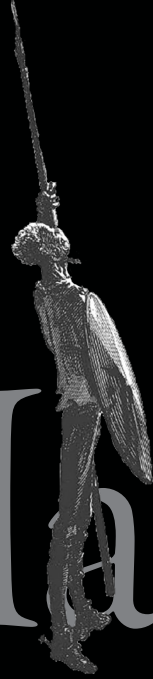

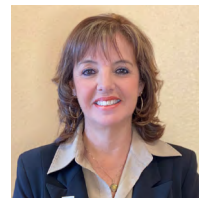

- Full Page with Bleed: 5.75" x 8.75"  
(Trim Size: 5.5" x 8.5" | Live Area: 5" x 8")
- 1/2 Page Horizontal: 4.5w" x 3.5h"
- 1/4 Page: 2.25" x 3.5"
- File Formats: pdf, jpg, png

**Trim Size:** 5.5" w x 8.5" h This is the final printed size of the program.

**Bleed Area:** Add 0.125" on all sides beyond the trim (final size: 5.75" x 8.75"). All background images or colors that extend to the edge must continue into the bleed area.

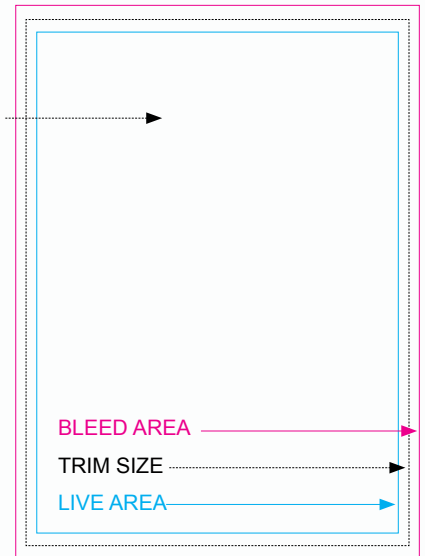
**Live Area (Safe Area):** 5" x 8" Keep all text, logos, and important content within this area to ensure nothing is cut off.

### Design Notes for Full Page Ads:

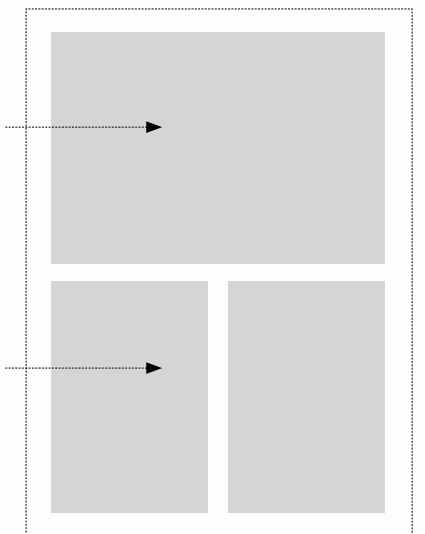
- Full-page ads should be supplied at 5.75" w x 8.75" h when using bleed.
- Files without bleed will be scaled to fit the live area, which may result in white borders.
- Keep all live content at least 0.25" from the trim edge.
- For two-page spreads, allow a 0.5" gutter and avoid placing key content in the center fold.
